In the event of any violation of any of the following terms and conditions Spring Creek Property Management shall have the right to immediately cancel and require the pet owner to immediately remove the pet from the premises. Cancellation of this agreement will not imply a waiver of the Tenant's responsibilities for any damage.

1ST AVENUE PROPERTY MANAGEMENT agrees to waive the pet restrictions of this rental agreement provided the Tenant and pet owner agree to and meet the following terms and conditions.

1. Only the pet(s) listed and described below are authorized under this agreement. Additional or other pets must be approved by Spring Creek Property Management
2. Pet(s) will not cause: danger, damage, nuisance, noise, health hazard, or soil the premises, grounds, common area, walks, parking areas, landscaping or gardens. Tenant agrees to clean up after the pet and agrees to accept full responsibility and liability for any damage, injury, or actions arising from or caused by his/her pet(s).
3. Tenant agrees to register the pet(s) in accordance with the local laws and requirements. Tenant agrees to immunize the pet(s) in accordance with the local laws and requirements.
4. Tenant warrants the pet(s) is house broken. Tenant warrants that the pet(s) has no history of causing physical harm to persons or property, such as biting, scratching, chewing, etc. Tenant further warrants that the pet(s) has no vicious history or tendencies.
5. The Tenant agrees to observe the following regulations:
  - (a) DOGS & CATS: Must be controlled at all times. Must be kept on a short leash while in common areas or on the grounds. Barking will not be tolerated in that it is considered to be a nuisance to other Tenants and neighbors. Proper disposal of cat litter (securely bagged) will be done on a frequent basis. Odors arising from cat litter will not be tolerated. Defecation in the yard shall be removed and discarded immediately in a secure, odor-proof bag or similar container. Urination or defecation in the interior may, if not sanitized to Owner's satisfaction, result in immediate termination of the rental agreement.
  - (b) BIRDS: Birds will be properly caged. Seeds, feed and droppings will be shielded or caught to prevent accumulation and/or damage to carpet and floors.

(c) FISH: Aquariums will not leak and will be cleaned regularly to prevent foul smelling water and/or odors.
